Background - ELIDZ



- □ In the context of the ELIDZ's Corporate Social Investment Policy, CSI is defined as: "The support by the ELIDZ, either financially or otherwise, in identified developmental areas, to organisations and projects that seek to address the social needs of communities and societyat-large in a positive and sustainable way."
- As such, the ELIDZ CSI Programme seeks to make a meaningful contribution to the promotion of social / community transformation and development, firstly in its immediate community and, secondly, throughout the greater Eastern Cape.





STRATEGIC COLLABORATION - Focus Areas



The ELIDZ's CSI Policy further identifies the following focus areas as the key pillars for ELIDZ activities:

Enterprise Development:
Providing support for Small,
Medium, and Micro Enterprises
(SMMEs) through coaching,
mentoring, partnerships, and
community business
development.

Education: Supporting literacy, numeracy, educational infrastructure, teacher support, scarce skills, and tertiary-level bursaries to address priority needs.

Sport and Youth Development:

Backing youth and sports
development, including
infrastructure upgrades, skills
development, and support for
sports teams.

Social and Community
Development: Enhancing
community infrastructure, social
cohesion, food security, and
advocating for local government
support to uplift neighbouring
communities.

Skills Development: Empowering the unemployed through skill development for employment and entrepreneurship, fostering socio-economic selfsustainability.

Discretionary: Allocating 15% of the CSI budget to strategic initiatives guided by ELIDZ leadership, considering stakeholder relations and corporate citizenship.

Support levels for each focus area are flexible, adapting to changing CSI needs and trends.

The ELIDZ CSI policy places emphasis on the following geographic spread of its CSI spend:

- 40% of spend to be prioritised on the immediate surrounding communities of Ward 46
- 35% of spend to be prioritised on the greater Buffalo City Metropolitan Municipality (BCMM) and former Border Region
- □ 25% of spend to be prioritised on the eastern rural part of the province.







ELIDZ's Approach for Community Collaboration: CSI Programmes



- Better Understanding of the Current Community Status: Gain a comprehensive understanding of the community's existing conditions.
- ☐ Proper Needs Assessment and Analysis: Conduct thorough needs assessments to provide relevant assistance that addresses specific community requirements.
- Empowerment over Donations: Prioritise empowering the community to be self-reliant instead of solely relying on donations.
- ☐ Collaboration with Recognised Community Leadership: Work in cooperation with established community leaders and organisations to ensure a more effective and sustainable impact.
- ☐ Presence and Visibility: Maintain a visible and active presence within the community to foster trust and engagement.
- Development of Partnerships: Establish and nurture partnerships with community stakeholders and organisations for a collective and impactful approach to community development.

Background- Phuthaditjhaba Industrial Park

Ч	Corporation (FDC), an official economic development agency for he Free State Province in South Africa.
	The mandate of the FDC is to provide support to SMMEs, manufacturing, trade, investment promotion and facilitation.
	The Park is strategically located in the Eastern Free State and 40 km away from N5 and N3 high ways. There are 115 Large and 181 small factory units totalling 296 units .
	Factories in the park are mainly rented for manufacturing and service industries and to a lesser extend retail i.e. wholesaling and storage with a lettable area of 257 360sqm and is sitting at 66% occupancy rate.
	The Park is counting for approximately 8000 jobs with R182 million investment.
	In terms of stakeholder relations we working closely with Department of Trade, Industry and Competition (DTIC), Free State Department of Economic Small Business Development Tourism and Environmental Affairs(DESTEA), Municipalities and other agencies in the Province.





Phuthaditjhaba IP – Projects & Initiatives

□ Signing of head leases in Residential and Commercial Property Portfolios (Shopping Centers & Residential flats) - Attraction of Private sector. ☐ Employment of local service providers and local people. ☐ Increase Occupancy rate by attracting investors and providing rental incentives in the Industrial and Commercial Properties. □ Cleaning Programme For Industrial Parks with the Department of Economic, Small Business Development, Tourism and Environmental Affairs – Destea (Employment of 50 community members for the period of twelve months). □ Reform Clothing and Textile Factories in Phuthaditjhaba Industrial Park with the Department of Economic, Small Business Development, Tourism and Environmental Affairs – Destea. Over 500 jobs to be created by assisting at least 10 factories in the park.





Phuthaditjhaba IP – Projects & Initiatives

- ☐ Free State Development Corporation entered into a strategic partnership with Maluti TVET College to assist in stimulation of district economy through enterprise development, training and special projects that will include skills development, trainings, business coaching and mentorship, business support and SMME development:
 - ☐ To instill entrepreneurial skills and mind-set to TVET College students and FDC Leaners.
 - ☐ FDC identified the TVET College as a skills development facility that has enrolled young people eager to learn about entrepreneurship and partake in the local economic development.
- □ A tripartite agreement with Small Enterprise Development Agency and Department of Economic, Small Business Development, Tourism and Environmental Affairs for POP Up Store to show case local manufactured products and exhibition thereof.





Eco-Industrial Parks Programme

EIP concept is about creating more resource-efficient and cost-effective industrial zones which are more competitive and risk resilient.
In collaboration with National Cleaner Production Centre South Africa (NCPC-SA) and the United Nations Industrial Development Organization (UNIDO), FDC has identified 6 EIP opportunities for which pre-feasibility studies have been completed.
The identified opportunities are aiming at mitigating challenges faced by the Industrialists and eventually collapsing the economy.
First phase of the programme focused on identification of the opportunities.
Second phase staring in 2024 will focus on implementation of the opportunities
