

# The Concept of Green Village

Nearly eighty years ago, Mahatma Gandhiji proclaimed that the soul of India lies in its villages. This sentiment still holds true today, with 6.4 million villages and 83.3 million people living in them, making up 65% of the population. Despite the noticeable migration to urban areas, the rural population has increased by 32% over the last two decades (1991–2011), necessitating the inclusion of rural areas in sustainable development efforts.

Today, major challenges faced in our villages are open defecation, drinking water scarcity, lack of adequate health care, access to basic amenities & school and power shortage. In the above context, converting existing villages to green and self-sustainable is of paramount importance to the Nation. IGBC Green Village rating is designed to address many of the rural challenges. The green concepts and techniques in the villages can help address National concerns like water availability, energy availability, reduction in fossil fuel use, handling of waste and conserving natural resources. Most importantly, these concepts can enhance health and wellbeing in villages, which is assuming greater importance.

Gangadevipalli is a village located 12 km from Warangal headquarters in Geesukonda Mandal, Warangal Rural district, Telangana. It has a population of 1352 people living in 287 houses. Gangadevipally did not have basic amenities including clean water, hospitals, schools, and work possibilities before 1993. There was only one well in the entire village, making it tough for the residents to have a decent living. In 1993, people came together with the help of Balavikasa and showcased a collective strength to demonstrate innovative approaches that were developed step-by-step in line with Gandhi's concept of Gram Swarajya, or a self-reliant village. IGBC Green Village certification with highest rating level 'Platinum' was offered to this village by IGBC after all the initiatives were assessed at Gangadevipally by IGBC Technical Committe. **The village has been visited by Bharat Forge team led by Dr Leena Deshpande, Head, Corporate Social Responsibility.**

## IGBC Green Village Initiative 5 Pilot Villages by Bharat Forge Ltd.


